## **New Information**

Effective January 1, 2019, ultra-low emission vehicles (ULEVs) will no longer be eligible for the clean air vehicle decal program. ULEVs were removed from the Application for Clean Air Vehicle Decals (REG 1000, REV. 1/2019) form (see Attachment A). The REG 1000 was further revised to include a chart explaining the gross annual income and vehicle type restrictions mandated by law, effective January 1, 2018.

The New Vehicle Dealer Application for Clean Air Vehicle Decals (REG 1000 D, REV. 1/2019) form (see Attachment B) reflects the same revision date as the REG 1000. On SECTION 3—CERTIFICATION of the REG 1000 D, the dealer certifies and signs under penalty of perjury that they agree to provide a new vehicle owner any clean air decal (CAD) issued in advance of a vehicle sale and the REG 1000 (REV. 1/2019) at the point of sale.

<p><b>NOTE:</b> Previous revisions of the REG 1000 and REG 1000 D will <b>not</b> be accepted after January 1, 2019.</p>

## **Procedures**

Continue to follow procedures in the *Vehicle Industry Registration Procedures Manual*, Chapter 25. The new REG 1000 (REV. 1/2019) **must** be used when processing applications that qualify for the CAD program.

## **Background**

Assembly Bill 544 (Chapter 630, Statutes of 2017) removed ULEVs from the CAD program.
