Heavy Duty Vehicle Registration Compliance

New Policy

Effective January 1, 2020, Senate Bill (SB) 1 requires the Department of Motor Vehicles (DMV) to verify that diesel-fueled vehicles with a gross vehicle weight rating (GVWR) over 14,000 pounds comply with the California Air Resources Board (CARB) Truck and Bus Regulations.

DMV will deny vehicle registration renewals or transfers for the following CARB non-compliant vehicles:

Effective Date	Vehicle Model Year	Weight
January 1, 2020	2004 and older	GVWR 14,001–26,000 pounds
	2000 and older	GVWR over 26,000 pounds
January 1, 2021	2007 and older	GVWR 14,001–26,000 pounds
	2005 and older	GVWR over 26,000 pounds
January 1, 2022	2007 and older	GVWR over 26,000 pounds
January 1, 2023	2010 and older	GVWR over 14,000 pounds

If the customer needs a temporary operating permit (TOP), one may be issued by DMV if all registration fees are paid as follows:

- The customer's receipt must be stamped with the date the TOP was issued.
- A second 90-day TOP can **only** be issued by the Technical Compliance Section (TCS) once CARB notifies TCS that one can be issued. The second TOP is automatically mailed to the customer upon notification from CARB.
 - —Refer customers that request a second 90-day TOP to the CARB Diesel Hotline at 1-866-634-3735, **not** TCS.

A new error message was created to identify non-compliant vehicles:

A new Record Condition Code (RCC) was created in Subrecord E to identify both compliant and non-compliant vehicles:

RCC	Description
85	ARB heavy-duty diesel registration for vehicles with a gross vehicle weight rating (GVWR) over 14,000 pounds.
	Reason Code 01 = ARB Compliant. Reason Code 02 = ARB Non-Compliant.

New Policy, continued

A new message was created and will appear in the middle of the renewal notice (see Attachment A) for vehicles that are **not** compliant with CARB Truck and Bus Regulations.

Procedures

Type transaction code (TTC) I00 and I05 are **not** permitted for diesel vehicles with a GVWR over 14,000 pounds with a 2010 model year or older. TTC H00 and H05 are required. When keying transactions for commercial vehicles with a GVWR over 14,000 pounds and error message Q208 is present, use the following guidelines:

NOTE: Clearance transaction—CARB updates the record five business days after the vehicle becomes CARB compliant.

Blanket Distribution

A blanket distribution of CARB bookmarks (see Attachment B), which includes CARB's website and information on how to comply with their emission regulations, will be sent to field offices.

Background

Currently, all diesel, natural gas, or propane-powered vehicles that weigh 14,001 pounds or more GVWR and 1997 and older model-year vehicles are not required to meet/comply with CARB's emission standards and are exempt from smog requirements.

Effective January 1, 2020, SB 1 (Chapter 5, Statutes of 2017) requires DMV to deny registration to diesel-powered vehicles with GVWR over 14,001 pounds that do not comply with CARB emission standards.

Air Regulation Compliance Verification Begins In 2020

Starting in 2020, vehicles subject to the California Air Resources Board's (CARB) Truck and Bus Regulation must meet the requirements of that rule to register with the DMV. This regulation helps to reduce harmful diesel emissions that put Californians at risk.

Am I subject to the regulation?

The regulation applies to nearly all privately- or federally-owned diesel-fueled trucks and buses, and privately- and publicly-owned school buses with a gross vehicle weight rating (GVWR) greater than 14,000 pounds.

How do I comply?

- Replace or repower your heavy-duty diesel vehicle with 2010 or newer engine based on the rule's engine model year schedule,
- Qualify for a flexibility option and report in CARB's Regulatory Reporting System (TRUCRS), or
- 3. Submit proof to CARB that the heavy-duty diesel vehicle is exempt from the regulation or does in fact have an engine model year of 2010 or newer. Visit arb.ca.gov/excludedtb for more information.
