For private schools "employment" means the act of engaging the services of a person, who will have contact with pupils, to work in a position at a private school at the elementary or high school level on or after September 30, 1997, on a regular paid full-time basis, regular paid part-time basis or paid full- or part- time seasonal basis pursuant to California Education Code §44327(b)(2).

NOTE: A parent or guardian instructing only their child is exempt from the criminal record summary requirement.
